



Section I Instructions to Bidders

A. General	
1 Scope of Bid & Source of Funds	<p>1.1 The Purchaser, as indicated in the Bid Data Sheet (BDS), issues these Bidding Documents for the supply of Goods and Related Services incidental thereto as specified in Section VI, Schedule of Supply. The name, identification number, and number of lots within this procurement are provided in the BDS</p> <p>1.2 Throughout these Bidding Documents:</p> <p>(a) the term “in writing” means communicated in written form (e.g. by mail, electronic mail, fax, telex) with proof of receipt;</p> <p>(b) if the context so requires, “singular” means plural” and vice versa; and</p> <p>(c) “day” means calendar day.</p> <p>1.3 The Employer as defined in section II, Bidding Data Sheet (BDS) has received a budget from RGoB towards the cost of the Goods defined in the BDS and intends to apply a part of the funds to cover eligible payments under this contract.</p>
2 Fraud & Corruption	<p>2.1 It is RGoB policy to require that Purchasers, Bidders, Suppliers, Contractors and their Subcontractors observe the highest standards of ethics during the procurement and execution of contracts. In pursuance of this policy, the RGoB:</p> <p>(a) defines, for the purposes of this provision, the terms set forth below as follows:</p> <p>(i) “Corrupt practice” is the offering, giving, receiving or soliciting, directly or indirectly, of anything of value to influence improperly the actions of another party;</p> <p>(ii) “Fraudulent practice” is any intentional act or omission, including a misrepresentation, that knowingly or recklessly misleads, or attempts to mislead, a party to obtain a financial or other benefit or to avoid an obligation;</p> <p>(iii) “Collusive practice” is an arrangement between two or more parties designed to achieve an improper purpose, including to influence improperly the actions of another party;</p> <p>(iv) “Coercive practice” is impairing or harming, or threatening to impair or harm, directly or indirectly, any party or the property of the party to influence improperly the actions of a party;</p> <p>(v) “Obstructive practice” is</p> <p>(aa) deliberately destroying, falsifying, altering or concealing of evidence material to the investigation or making false statements to investigators in order materially to impede any investigation into allegations of a corrupt, fraudulent, coercive or collusive practice;</p>

	<p>and/or threatening, harassing or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation; or</p> <p>(bb) acts intended materially to impede the exercise of the inspection and audit rights of the Purchaser or any organization or person appointed by the Purchaser and/or any relevant RGoB agency provided for under ITB Sub-Clause 2.1 (d) below.</p> <p>(b) will reject a proposal for award if it determines that the Bidder recommended for award has, directly or through an agent, engaged in corrupt, fraudulent, collusive, coercive or obstructive practices in competing for the contract in question;</p> <p>(c) will sanction a firm or individual, including declaring them ineligible, either indefinitely or for a stated period of time, to be awarded an RGoB-financed contract if it at any time determines that they have, directly or through an agent, engaged in corrupt, fraudulent, collusive, coercive or obstructive practices in competing for, or in executing, an RGoB-financed contract;</p> <p>(d) will have the right to require that a provision be included in Bidding Documents and in contracts financed by the RGoB, requiring Bidders, Suppliers, Contractors and their Subcontractors to permit the Purchaser, any organization or person appointed by the Purchaser and/or any relevant RGoB agency to inspect their accounts and records and other documents relating to their Bid submission and contract performance and to have them audited by auditors appointed by the Purchaser;</p> <p>(e) requires that Bidders, as a condition of admission to eligibility, execute and attach to their bids an Integrity Pact Statement in the form provided in Section IV, Bidding Forms as specified in the BDS. Failure to provide a duly executed Integrity Pact Statement may result in disqualification of the Bid; and</p> <p>(f) will report any case of corrupt, fraudulent, collusive, coercive or obstructive practice to the relevant RGoB agencies, including but not limited to the Anti-corruption Commission (ACC) of Bhutan, for necessary action in accordance with the statutes and provisions of the relevant agency.</p> <p>2.2 Furthermore, Bidders shall be aware of the provision stated in Sub-Clause 36.1 (a) (iii) of the General Conditions of Contract.</p>
<p>3 Eligible Bidders</p>	<p>3.1 A Bidder, and all parties constituting the Bidder, may have the nationality of any country, subject to the restrictions specified in Section V, Eligible Countries. A Bidder shall be deemed to have the nationality of a country if the Bidder is a citizen or is constituted, incorporated, or registered and operates in conformity with the provisions of the laws of that country. This criterion shall also apply to the determination of the nationality of proposed subcontractors or suppliers for any part of the Contract including Related Services.</p>

	<p>3.2 A Bidder shall not have a conflict of interest. All Bidders found to have a conflict of interest shall be disqualified. Bidders may be considered to have a conflict of interest with one or more parties in this bidding process if they:</p> <ul style="list-style-type: none"> (a) are associated, or have been associated in the past, with a firm or any of its affiliates which has been engaged by the Purchaser to provide consulting services for the preparation of the design, specifications and/or other documents to be used for the procurement of the Goods to be purchased pursuant to these Bidding Documents, or (b) submit more than one Bid in this bidding process, except for alternative offers permitted under ITB Clause 15. However, this does not limit the participation of subcontractors in more than one Bid. (c) employ or otherwise engage, either directly or through any of their affiliates, a spouse, dependent or close relative of a public servant of the RGoB who either is employed by the Purchaser or has an authority over it. For the purposes of this Sub-Clause a close relative is defined as immediate family which includes father, mother, brother, sister, spouse and own children. <p>3.3 Government-owned enterprises in Bhutan shall be eligible only if they can establish that they (i) are legally and financially autonomous, (ii) operate under commercial law, and (iii) are not a dependent agency (directly or indirectly) of the Purchaser.</p> <p>3.4 A Bidder that is under a declaration of ineligibility pursuant to ITB Sub-Clause 2.1 (c) shall not be eligible to participate in this bidding process in any capacity.</p> <p>3.5 Bidders shall provide such evidence of their continued eligibility satisfactory to the Purchaser as the Purchaser shall reasonably request.</p>
<p>4 Exclusion of Bidders</p>	<p>4.1 A Bidder shall be excluded from participating in this bidding process under the following circumstances:</p> <ul style="list-style-type: none"> (a) as a matter of law or official regulation, RGoB prohibits commercial relations with the country in which the Bidder is constituted, incorporated or registered; or (b) by an act of compliance with a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations, RGoB prohibits (i) any import of Goods or contracting of Services from the country in which the Bidder is constituted, incorporated or registered or (ii) any payments to persons or entities in that country; or (c) he is insolvent or is in receivership or is a bankrupt or is in the process of being wound up; or has entered into an arrangement with creditors; or (d) his affairs are being administered by a court, judicial officer or appointed liquidator; or (e) he has suspended business or is in any analogous situation arising from similar procedures under the laws and regulations of his country of establishment; or (f) he has been found guilty of professional misconduct by a recognized

	<p>tribunal or professional body; or</p> <p>(g) he has not fulfilled his obligations with regard to the payment of taxes, social security or other payments due in accordance with the laws of the country in which he is established or of the Kingdom of Bhutan; or</p> <p>(h) he is guilty of serious misrepresentation in supplying information in his tender; or</p> <p>(i) he has been convicted for fraud and/or corruption by a competent authority; or</p> <p>(j) he has not fulfilled any of his contractual obligations with the Purchaser in the past.</p> <p>(k) he has been debarred from participation in public procurement by any competent authority as per law.</p>
5. Eligible Goods & Related Services	<p>5.1 All the Goods and Related Services to be supplied under the Contract may have their origin in any country in accordance with Section V, Eligible Countries.</p> <p>5.2 For the purposes of this Clause, the term “Goods” includes commodities, raw material, machinery, equipment and industrial plants; and “Related Services” includes services such as insurance, installation, training, and initial maintenance.</p> <p>5.3 The term “origin” means the country where the Goods have been mined, grown, cultivated, produced, manufactured or processed; or, through manufacture, processing, or assembly, another commercially recognized article results that differs substantially in its basic characteristics from its components.</p>

6. Parts of Bidding Documents	<p>6.1 The Bidding Documents consist of Parts 1, 2 and 3, which include all the Sections indicated below, and should be read in conjunction with any Addenda issued in accordance with ITB Clause 9.</p>

7. General Information	<p>7.1 The Invitation for Bids issued by the Purchaser is not part of the Bidding Documents.</p> <p>7.2 The Purchaser is not responsible for the completeness of the Bidding Documents and their addenda, if any, if these were not obtained</p>

	<p>directly from the Purchaser.</p> <p>7.3 The Bidder is expected to examine all instructions, forms, terms and specifications in the Bidding Documents. Failure to furnish all information or documentation required by the Bidding Documents may result in the rejection of the Bid.</p>
8. Clarification of Bidding Documents	<p>8.1 Bidders shall not be allowed to seek any clarification of the Bidding Documents in person or by telephone or other verbal means.</p> <p>8.2 A prospective Bidder requiring any clarification of the Bidding Documents shall notify the same to the Purchaser in writing at the Purchaser's address specified in the BDS;</p> <p>8.3 The Purchaser shall respond in writing to any such request for clarification, provided that it is received no later than fifteen (15) days prior to the deadline for submission of Bids. Copies of the Purchaser's response shall be forwarded to all those who have acquired the Bidding Documents directly from the Purchaser, including a description of the enquiry without disclosing the name of the Bidder(s) seeking clarification. Should the Purchaser deem it necessary to amend the Bidding Documents as a result of a clarification, it shall do so following the procedure under ITB Clause 9 and ITB Sub-Clause 27.2; and</p> <p>8.4 A pre-bid meeting shall be conducted only if strictly necessary to clarify doubts and concerns of the Bidders prior to submission of Bids. Minutes of the pre-bid meeting shall be circulated to all Bidders that have purchased Bidding Documents.</p>
9. Amendment of Bidding Documents	<p>9.1 At any time prior to the deadline for submission of Bids the Purchaser may amend the Bidding Documents by issuing an addendum. This may be done either on the Purchaser's own initiative or in response to a clarification request from a prospective Bidder.</p> <p>9.2 Any addendum thus issued shall be part of the Bidding Documents and shall be communicated in writing to all who have obtained the Bidding Documents directly from the Purchaser. Such addendum shall be binding on the prospective Bidders, and shall require that prospective Bidders confirm receipt of it before the time established for the opening of Bids;</p> <p>9.3 The Purchaser may, at its discretion, extend the deadline for submission of Bids pursuant to ITB Sub-Clause 27.2 to allow prospective Bidders reasonable time in which to take the addendum into account in preparation of their Bids.</p>
C. Preparation of Bids	
10. Cost of Bidding	<p>10.1 The Bidder shall bear all costs associated with the preparation and submission of its Bid, and the Purchaser shall not be responsible or liable for those costs, regardless of the conduct or outcome of the Bidding process.</p>
11. Language of Bid	<p>11.1 The Bid, as well as all correspondence and documents relating to the Bid exchanged by the Bidder and the Purchaser, shall be written in the language specified in the BDS. Supporting documents and printed literature that are part of the Bid may be in another language provided they are accompanied by an accurate translation of the relevant passages in the language specified in the BDS, in which case, for the</p>

	purposes of interpretation of the Bid, such translation shall govern.
12. Documents Comprising the Bid	<p>12.1 The Bid shall comprise the following:</p> <ul style="list-style-type: none"> (a) Bid Submission Sheet and the applicable Price Schedules in accordance with ITB Clauses 13, 14, 16 and 18; (b) Bid Security, in accordance with ITB Clause 24; (c) Written confirmation authorizing the signatory of the Bid to commit the Bidder, in accordance with ITB Clause 25; (d) Documentary evidence in accordance with ITB Clause 19 establishing the Bidder's eligibility to bid; (e) Documentary evidence in accordance with ITB Clause 20 that the Goods and Related Services to be supplied by the Bidder are of eligible origin; (f) Documentary evidence in accordance with ITB Clauses 21 and 33 that the Goods and Related Services conform to the Bidding Documents; (g) Documentary evidence in accordance with ITB Clause 22 establishing the Bidder's qualifications to perform the contract if its Bid is accepted; (h) Alternative Bids, if permissible, in accordance with ITB Clause 15; (i) Documentary evidence or certified statements that the Bidder is not in any of the exclusion categories stipulated in ITB Sub-Clause 4.1; (j) Integrity Pact Statement, in accordance with ITB Sub-Clause 2.1 (e) as specified in BDS; and (k) Any other document required in the BDS.
13. Bid Submission Sheet	<p>13.1 The Bidder shall submit the Bid Submission Sheet using the form furnished in Section IV, Bidding Forms. This form must be completed without any alterations to its format, and no substitutes shall be accepted. All blank spaces shall be filled in with the information requested.</p>
14. Price Schedules	<p>14.1 The Bidder shall submit the Price Schedules for Goods and Related Services, according to their origin as appropriate, using the forms furnished in Section IV, Bidding Forms.</p>
15. Alternative Bids	<p>15.1 Unless otherwise indicated in the BDS alternative Bids shall not be considered.</p>

<p>16. Bid Prices & Discounts</p>	<p>16.1 The prices and discounts quoted by the Bidder in the Bid Submission Sheet and in the Price Schedules shall conform to the requirements specified below.</p> <p>16.2 All lots and items in the Schedule of Supply must be listed and priced separately in the Price Schedules.</p> <p>16.3 The price to be quoted in the Bid Submission Sheet shall be the total price of the Bid excluding any discounts offered.</p> <p>16.4 The Bidder shall quote any unconditional discounts and the methodology for their application in the Bid Submission Sheet.</p> <p>16.5 The terms EXW, CIF, CIP and other similar terms shall be governed by the rules prescribed in the current edition of Inco terms, published by The International Chamber of Commerce as specified in the BDS.</p> <p>16.6 Unless otherwise stated in the BDS, Prices shall be quoted inclusive of all applicable taxes and levies, insurance, transportation, handling costs and any other associated cost to fulfill the contractual obligations, as specified in the Price Schedule forms for Goods and related services included in Section IV Bidding Forms. INTEGRITY PACT

1. General

Whereas, **Dasho Dzongdag** representing the **Dzongkhag Administration Sarpang**, Royal Government of Bhutan, hereinafter referred to as the Employer on one part, and _____ (*Name of Person*) representing the _____ (*Name of Bidder*) as the other part hereby execute this agreement as follows:

This agreement should be a part of the tender document, which shall be signed and submitted along with the tender document. The head of the employing agency/or his authorized representative should be the signing authority. For the bidders, the bidder himself or his authorized representative must sign the Integrity Pact (IP). If the winning bidder had not signed during the submission of the bid, the tender shall be cancelled.

2. Objectives

Now, therefore, the Employer and the Bidder agree to enter into this pre-contract agreement, hereinafter referred to as Integrity Pact, to avoid all forms of corruption by following a system that is fair, transparent and free from any influence/unprejudiced dealings prior to, during and subsequent to the currency of the contract to be entered into, with a view to:-

- 2.1 Enabling the Employer to obtain the desired contract at a reasonable and competitive price in conformity to the defined specifications of the works, goods and services; and
- 2.2 Enabling bidders to abstain from bribing or any corrupt practice in order to secure the contract by providing assurance to them that their competitors will also refrain from bribing and other corrupt practices and the Employer will commit to prevent corruption, in any form by their officials by following transparent procedures.

3. Commitments of the Employer:

The Employer Commits itself to the following:-

- 3.1 The Employer hereby undertakes that no official of the Employer, connected directly or indirectly with the contract, will demand, take a promise for or accept, directly or through intermediaries, any bribe, consideration, gift, reward, favor or any material or immaterial benefit or any other advantage from the Bidder, either for themselves or for any person, organization or third party related to the contract in exchange for an advantage in the bidding process, bid evaluation, contracting or implementation process related to the Contract.
- 3.2 The Employer further confirms that its officials has not favored any prospective bidder in any form that could afford an undue advantage to that particular bidder during the tendering stage, and will further treat all the Bidders alike.
- 3.3 All the officials of the Employer shall report to the head of the employing agency or an appropriate Government office any attempted or completed violation of clauses 3.1 and 3.2.

- 3.4 Following report on violation of clauses 3.1 and 3.2 by official (s), through any source, necessary disciplinary proceedings, or any other action as deemed fit, including criminal proceedings may be initiated by the Employer and such a person shall be debarred from further dealings related to the contract process. In such a case while an enquiry is being conducted by the Employer the proceedings under the contract would not be stalled.

4. Commitments of Bidder

The bidder commits himself to take all measures necessary to prevent corrupt practices, unfair means and illegal activities during any stage of his bid or during any pre-contract or post-contract stage in order to secure the contract or in furtherance to secure it and in particular commits himself to the following:-

- 4.1 The bidder will not offer, directly or through intermediaries, any bribe, gift, consideration, reward, favor, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the Employer, connected directly or indirectly with the bidding process, or to any person, organization or third party related to the contract in exchange for any advantage in the bidding, evaluation, contracting and implementation of the Contract.
- 4.2 The Bidder further undertakes that he has not given, offered or promised to give, directly or indirectly any bribe, gift, consideration, reward, favor, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the Employer or otherwise in procuring the Contract or forbearing to do or having done any act in relation to the obtaining or execution of the Contract or any other contract with the Government for showing or forbearing to show favor or disfavor to any person in relation to the Contract or any other contract with the Government.
- 4.3 The Bidder will not collude with other parties interested in the contract to preclude the competitive bid price, impair the transparency, fairness and progress of the bidding process, bid evaluation, contracting and implementation of the contract.

- 6. Conflict of Interest**

Conflict of Interest would arise in a situation when any concerned members of both the parties are related either directly or indirectly, or has any association or had any confrontation. Thus, conflict of interest of any tender committee member must be declared in a prescribed form (sample form attached).
 - 6.2 The Bidder shall not lend to or borrow any money from or enter into any monetary dealings or transactions, directly or indirectly, with any committee member, and if he does so, the Employer shall be entitled forthwith to rescind the Contract and all other contracts with the Bidder.
- 7. Examination of Books of Accounts**
- 7.1 In case of any allegation of violation of any provisions of this Integrity Pact or payment of commission, the Employer/authorized person or relevant agencies shall be entitled to examine the Books of Accounts of the Bidder and the Bidder shall provide necessary information of the relevant financial documents and shall provide necessary information of the relevant financial documents and shall extend all possible help for the purpose of such examination.
- 8. Monitoring & Arbitration**
- 8.1 The respective procuring agency shall be responsible for monitoring and arbitration of IP as per the Procurement Rules.
- 9. Legal Actions**
- 9.1 The actions stipulated in this Integrity Pact are without prejudice to any other legal actions that may follow in accordance with the provisions of the extant law in force relating to any civil or criminal proceedings.

10. Validity

- 10.1 The validity of this Integrity Pact shall cover the tender process and extend until the completion of the contract to the satisfaction of both the Employer and the Bidder.
- 10.2 Should one or several provisions of this Pact turn out to be invalid; the remainder of this Pact remains valid. In this case, the parties will strive to come to an agreement to their original intentions.

I. General Specifications

- a) The bridges shall be strictly standard "**Bailey Type**" portable steel truss bridge
- b) The bridges shall have single lane carriage width of at least **3.277metres**.
- c) The decking shall be steel with anti-skid chequered surface
- d) The size of joists for Steel deck transoms for full set as well as components shall be 300 x 140 mm.
- e) The bridge parts shall be supplied as a **full unit** against the bridge span and the construction type mentioned in **Price Schedule – Part I, II& III**. For each unit the supplier/manufacturer shall supply all the necessary parts in complete.

Components like Panel pins, split pins, Short Chord, Long chord & HD bolts, transom clamps etc. shall be 10% extra along with the mandatory requirement of the bridge components.

- f) The construction types TS mentioned in **Price Schedule** are only suggestive. The most important is that the bridges shall have **guaranteed load carrying Capacity of at least Class 24Ras per Indian Road Congress Specifications, IRC - 6.**

To this end, as a part of the supply contract, the manufacturer/supplier has to submit a signed letter of guarantee to the Client as regards the load capacity of the bridges.

- g) In case of double span bridges, the two spans of the bridges shall be separated at the intermediate pier so that each span is simply supported. Therefore, the supply shall include the bridge parts required for providing the smooth connectivity between the two spans.

II. Protective painting works

- a) The final color shade of the paint shall be **Army Green**
- b) All corrosion protection works shall be carried out as per the guidelines of ISO **12944** "Paints and varnishes - Corrosion protections of steel structures by protective paint systems".
- c) All steel structures to be covered with coating system shall be prepared at worksite (workshop of the steel manufacturer) by blast-cleaning using mineral abrasive agent or steel grit up to the degree A/B **SA 21/2** according to ISO 12944, Part 4. All dust shall be removed by pressured air or vacuum cleaner.
- d) The prepared surfaces shall be covered with the priming coat within 4 hours, max. in the same day to avoid new rusting.

e) **Coating System**

- 1) Shall be as per ISO 12944, Part 5, Table A3 and fulfill the following minimum requirement
- 2) The corrosion protection shall be designed for "**long protection > 15 years**" according ISO 12944, Part 1 and Part 5, Ciphers 5.5. Alkali-resistant coating shall be applied.
- 3) All the coating layers specified below shall be completed at the manufacturer's plant.
 - a. Priming coat with 2-pack epoxy zinc-phosphate primer e.g. ICOSIT EG Phosphate. Color shade red-brown. Minimum dry film 60 microns. Application by brush, roller or airless-spraying. Edges and welding seams shall be pre-coated by brush. Waiting time before applying the intermediate coat shall be minimum 24 hours,
 - b. Intermediate coat with 2-pack epoxy micaceous iron oxide coating e.g. ICOSIT EG 1. Color shade dark-grey. Minimum dry film thickness 60 microns. Application by brush, roller or airless-spraying. Hardening time before transport to the site of at least 5 days shall be allowed.
 - c. First top coat with 2-pack epoxy micaceous iron oxide coating e.g. ICOSIT EG 1. Minimum dry film thickness 60 microns, application by brush or roller, eventually airless-spraying. Waiting time of at least 24 hrs shall be allowed before applying the 2nd top coat.
 - d. Second top coat with 2-pack polyurethane micaceous iron oxide coating, stable to UV and weathering e.g. ICOSIT EG 4, color shade army green. Minimum dry film thickness 60 microns. Application by brush or roller, eventually airless-spraying.
 - e. The application and quality control of the coatings shall be in accordance with ISO 12944, Part 7, and as per the technical data sheet of the manufacturer.

III. Galvanization

Galvanization is the process by which steel components are protected against corrosion by zinc coating applied by dipping them in a bath of molten zinc. The preparation for this process includes de-greasing, washing, pickling in hydrochloric acid to remove rust & scale, rinsing, flux treatment to remove any remaining impurities. This is followed by hot dip galvanizing in a bath of zinc at about 450° C.

The galvanization process causes the formation of a coating consisting of layers of zinc-iron alloy. As the components are withdrawn from the bath, a further layer of nearly pure zinc remains on the surface. The resulting thickness of the zinc coating is dependent on the material thickness, but is typically a minimum of 85 microns (0.085 mm) or 610 gms/m².

A galvanized coating has excellent resistance to damage as the zinc/iron alloys, which normally comprise about two-thirds of the coating, are harder than mild steel and give good abrasion resistance, whereas the outer layer of zinc is comparatively soft & provides a cushion against impact damage.

The galvanized coating has the added advantage of providing sacrificial protection if steel is exposed. Small areas such scratches or chipping will be completely protected but even if the area is somewhat larger, the sacrificial protection will prevent any rust that might occur from spreading under the coating.

The galvanization shall be carried out strictly as per relevant IS Codes.

5. Inspections & Tests

Bridge construction involves public safety issues besides incurring huge investment on the part of the Client. Therefore, anytime during manufacturing process of the bridge parts, the Client will dispatch a team of competent officers to carry out the quality inspection of the bridge parts at the manufacturer's yard. The inspection team will verify particularly the steel material, fabrication process, trail assembly & quality and the protective painting works among others.

The factory inspection will be done by either a third party or the Client at the cost of the Client.

The manufacturer shall inform the Client **at least two weeks** in advance for deputing the Inspection team.

The quality of fabricated bridge parts shall be checked strictly and if found to be of inferior quality or not up to the required standards and specifications, the parts will be unconditionally rejected. The supplier must replace the rejected items or lot with materials / parts of confirming to specifications & of required quality. Additional cost for replacement **has to be borne** by the Supplier. The rejected parts have to be replaced within the time allowed.

Should the supplier fail to replenish the rejected lot (s) or item within the allowed time, the purchaser has the right to get the **bridge parts** from other source at the cost and risk of the defaulting supplier.

Under no circumstances the sub-standard quality or expired self-life material shall be supplied by the bidder during the entire period of contractual agreement.

The purchaser may also to conduct third party laboratory test independently should the requirement so demands.

It is made clear here that the inspection team's verification of the bridge parts doesn't relieve the manufacturer/supplier of its responsibilities as regards the quality and hence the safety of the bridge parts supplied by them as a part of this contract.

The Bidder shall indicate the source of the indices and the base date indices in its bid.

Base date = thirty (30) days prior to the deadline for submission of the bids.

Date of adjustment = _____ weeks prior to date of shipment (representing the mid-point of the period of manufacture).

The above price adjustment formula shall be invoked by either party subject to the following further conditions:

- (a) No price adjustment shall be allowed beyond the original delivery dates unless specifically stated in the extension letter. As a rule, no price adjustment shall be allowed for periods of delay for which the Supplier is entirely responsible. The Purchaser will, however, be entitled to any decrease in the prices of the Goods and Services subject to adjustment.
- (b) If the currency in which the Contract Price P_0 is expressed is different from the currency of origin of the labor and material indices, a correction factor will be applied to avoid incorrect adjustments of the Contract Price. The correction factor shall correspond to the ratio of exchange rates between the two currencies on the base date and the date for adjustment as defined above.
- (c) No price adjustment shall be payable on the portion of the Contract Price paid to the Supplier as advance payment.
